Letter from Our Leadership Team

Dear Parishioners,

As we wind down another calendar year and begin a new liturgical year on the First Sunday of Advent, we share our 2020 Annual Report. Together, we have made great strides, moving swiftly yet thoughtfully during our first complete fiscal year united as Saints Joseph and Francis Xavier Parish, even despite the unforeseen challenges of a fourth quarter pandemic. We remind you that the Archdiocese of Chicago's fiscal year runs from July 1 to June 30, so our final quarter was April – June of 2020.

As you read this report, we ask you to consider your commitment to Saints JFX. Stewards share their time, talent, and treasure. We have many reasons to celebrate and give thanks. This annual report, however, makes clear that the expense of running our parish and school significantly outweighs our income (contributions combined with tuition and fees). While many give generously to support our work, we implore more parishioners to contribute regularly.

We have much to celebrate:

- We are one Parish! While this process started two years ago, it feels like we have successfully integrated this year to become one parish, one community and one school. Thanks to your help, patience and partnership, we have successfully integrated into one community in Saints JFX.
- Our school, Youth Faith Formation and ACTION programs are all thriving. We continue to offer one of the best educational and spiritual experiences in the North Shore community.
- We successfully reopened the church and school during the pandemic! The pandemic has challenged us all in many ways, and we are especially proud of how we've evolved as a faith community. We created a virtual Mass experience to get through the lock down, and we worked to reopen the church for in-person worship with extensive planning and organization by parish staff and the training and dedication of countless volunteers. Parishioners of all ages reached out to every member of the community by phone to offer support and connection and we added two car Masses (among the most popular Masses ever).
- Two parishioners are in training or have completed the Deacon Program.
- We've completed many necessary renovations at our school and church buildings to keep them safe while preserving their historic charm and character.
- Alongside our classroom curricula, we offer many programs for adult faith formation.

At the same time, we are aware that we have a long way to go towards good stewardship and fiscal responsibility. For over a decade, both St. Joseph and St. Francis Xavier have been operating at deficits that are not sustainable. It is imperative that we address this fiscal imbalance. The expenses of running our parish and school significantly outweigh our income. We had a \$276,464 shortfall for fiscal year 2020. This was a significant improvement from a shortfall of \$909,510 for 2019. **However, given the pandemic impact on our expenses and income, we project the shortfall for our current year will increase to \$582,253.** With this understanding, we have taken some key actions toward fiscal responsibility that we list below.

Key Actions toward fiscal responsibility:

- Established a Fiscal Sustainability Task Force comprised of leaders from the respective constituencies to advise us on best practices and ways to move forward.
- Worked with a cross functional Stewardship Committee to find ways to further engage this great community, sharing our gifts here and beyond.
- Continued to work with the Finance Council on finding greater efficiencies and cost reductions.
- Secured aid from the Federal Payroll Protection Program, which has helped us alleviate some of the financial impact from the pandemic.
- Increased online contributions from parishioners and with greater regularity.

We need your help:

- We ask that you take time to prayerfully reflect and determine how you can contribute further to our school and parish whether it be your time, talent and/or treasure.
- As you think about your charitable giving in the years ahead, we ask that you make Saints JFX your first and most important priority.
- Please contribute via electronic giving at <u>GiveCentral.org</u>, so we can budget appropriately and rely on your uninterrupted support.
- Keep us in mind as you finalize your tax planning in 2020. Please consider a gift to Saints JFX, especially if you have highly appreciated securities. These are truly a win-win for you and the parish!




Financial Highlights






Financial Highlights

(2) The Parish received a total loan of \$1,125,337 as part of the SBA Paycheck Protection Program (PPP). It is anticipated that 100% of this loan will be forgiven.

(3) The Building Fund Savings Account relates to donations received to support current buildings and grounds capital projects across both the SFX and SJ campuses.

(4) Includes restricted funds from second collections required by the Archdiocese of Chicago including Annual Catholic Appeal, Aid for Central & Eastern Europe, Catholic Charities, Retired Priests Fund, and Peter's Pence.

(5) Includes funds designated for sharing parishes including St. Ignatius, St. Thomas School & Food Pantry, Saint Vincent de Paul, and the Father Rodlin Fund.

(6) The Saint Vincent de Paul (SVDP) group manages the investment of funds restricted for the long term use of the SVDP mission.

(7) These funds were designated as restricted when our parish finances were merged. These specific restrictions are still in the process of being allocated in order to ensure they are properly accounted.



(11) SJ Local To Teach Who Christ Is (TTWCI) Capital Campaign: Net outstanding receivable pledges totals less than \$75,000. All remaining funds are restricted and are to be used for purposes laid out in the original case statement.

Key Restricted Assets & Endowments



(1) The school scholarship fund received additional funding of \$11,673 (donations and interest) during fiscal 2020. There were no disbursements taken from this account.

(2) The EPIC fund received additional funding of \$95,682 during fiscal 2020 and distributed \$99,042 for a variety of initiatives including teacher self-care initiatives, an updated sound system in the gym, updated e-learning technology, and school furnishings. The EPIC fund inspires teachers to propose new existing innovative learning experiences for students and underwrites impactful, best-of-class professional development for faculty across grades and disciplines.

(3) The Parish Endowment Fund comprises the legacy endowment funds for SFX and SJ. The significant majority of today's fund was originally created by a bequest to the legacy SFX endowment from the family of Vivienne Morin for the purpose of enriching the pastoral ministry of the parish, including adult education, liturgical needs, ministerial expenses and charitable needs of the community. Changes in the value of the endowment are attributable to changes in the market value of investments.

(4) The School Endowment fund comprises the SFX General School Fund and the Louise Murphy Scholarship Fund. The increase in the balance of the school endowment is attributable to the repayment of the loan made to SFX for the construction of the school atrium and gym.



Key Parish Ministry Highlights

Saints JFX parishioners have a long history of generosity and steadfast support of those less fortunate. In FY20, our parish generously donated nearly \$650,751 to Haiti, Saint Vincent de Paul, sharing parishes, Archdiocesan second collections and many others. Amid the fear and economic fallout of a deadly pandemic, your generosity has allowed us to support a continuum of compassionate care.

Immaculée Concepcion Parish (Haiti). Since 2011, funds raised through our second collections continue to provide a quality Catholic education to many students and cover the teacher salaries. This past year saw both triumph and tragedy. In September 2019, a delegation of parishioners traveled to celebrate the formal opening of the new school. Bishop Vital Médé, the vicar general of the Archdiocese of Port-au-Prince and long-time supporter of our efforts, concelebrated with Pastor Benjamin Exantus. It was a vibrant and moving event. Sadly, Bishop Médé unexpectedly passed away from COVID-19 on June 8, 2020. He will be long remembered for his unwavering support of our efforts over many years and for his moving homily at the inaugural mass. The new school building remains open and thriving despite the COVID-19 challenges.



Annual Catholic Appeal. The Annual Catholic Appeal is a fundraising campaign that supports the parishes, schools, ministries, programs and agencies that serve the educational, physical and spiritual needs of the people of the Archdiocese of Chicago. Through Catholic Relief Services, the Appeal also serves people around the world, regardless of religious affiliation, whose lives are devastated by natural disasters, illnesses, wars and famine. Since we exceeded the combined 2019 goal of \$145,780 set by the Archdiocese, \$42,833 was returned to the parish.

St. Thomas of Canterbury School and Food Pantry. St. Thomas is a small but richly diverse parish in Chicago's Uptown area, serving about 200 families from 37 countries. St. Thomas School provides high quality education to primarily immigrant or second generation students. Over 95% of these students' families have incomes below the poverty line. COVID-19 has greatly increased both the number of needy families and the school expenses in the school.

Our parishioners contribute financially, tutor students, assist with financial scholarships applications, donate Chromebooks, and sew masks.

St. Vincent de Paul. The Society of St. Vincent de Paul offers assistance to those in need. The first priority is to provide direct, personal communication. Volunteers respond to calls for assistance, meet with clients, offer help to pay bills, and assist with merchandise cards. We aim to provide short-term aid while those in need search for long-term support.

Catholic Charities. Catholic Charities sees the face of God in those in need through the provision of food, clothing, shelter and counseling. In 2019, the parishioners of Saints JFX and Father Watts were honored with the Catholic Charities Parish Partner Award for living the Gospel and supporting those in need. We have been strong supporters of fundraising campaigns and have supported Tuesday Night Supper, food pantry and clothing drives, rent for the New Hope apartments, and served as program site for the Behavioral Health Program. By supporting Catholic Charities, we help bring hope to the hopeless in Chicago and its suburbs.



St. Ignatius. St. Ignatius is a diverse Parish in Rogers Park. In 2019-20, the Saints JFX Parish frequently filled the food pantries at St. Ignatius with regular food drives including the Epiphany cereal drive in January, "Souper" bowl canned soup collection in February, the Give from the Heart food drive collection and a "Fill the Bag" food drive last fall. In addition, we also funded the replacement of the freezer in their food kitchen.

Our Commitment to Religious Education

Catholic School Education

For well over a century, the Schools of Saints JFX have prepared thousands of students to make a difference in the world through an intentional combination of faith and academics. Catholic faith, sound values and academic integrity serve as guiding principles and remain critical to our schools'

continued success. During the 2019-2020 academic year, St. Joseph and St. Francis Xavier were home to 625 students spanning preschool through eighth grade. Both schools have been recognized for academic excellence with the prestigious National Blue-Ribbon Schools Award: St. Francis Xavier School in 2012 and again in 2018 (in its first year of re-eligibility), and St. Joseph School in 2017. In recent years, our schools have expanded and diversified both the range and expertise across faculty and support staff, classroom resources, curricular offerings, programs, and services. Students are appropriately



challenged and lovingly supported by a robust range of specialists in areas including occupational therapy, speech and literacy intervention, math and reading differentiation and faculty coaching. Our students are prepared to excel in high school and beyond. Our alumni attend some of the nation's finest colleges and universities and excel as academically inspired, faith-filled, and socially conscious individuals who seek to make the world a better place.

Youth Faith Formation (YFF)

Our youth religious education program unified at the end of the fiscal 2020 year and developed into "Youth Faith Formation". The respective programs, prior to unification, served approximately 700 children in preschool through eighth grade, in addition to our Spred program (Special Religious Development) which served 6 students. Many dedicated catechists teach our parish children in the Catholic doctrine and, by their example, encourage them to engage in community service. Several of our wonderful parish teenagers also assist with this program. Our students attended classes from a variety of area public schools and share the bond of communion and faith. Our entire parish family is blessed and enriched by our YFF ministry!



Saints JFX ACTION

This wonderful program for high school students continues with Sunday evening Masses, which allows our teenagers to gather and socialize at a safe distance. Mass is led by our wonderful parish priests and the young adults and the program is evolving and thriving.

Adult Faith Formation

The Rite of Christian Initiation for Adults (RCIA) is the Church's process of welcoming people to the Catholic way of life. People interested in being baptized, confirmed and receiving Eucharist participate in a small group setting to inquire, learn and discern if this is compatible with what they seek. The process typically culminates at the Easter Vigil with the reception of the sacraments of initiation. In July 2020, we welcomed 6 new members into full communion with the Roman Catholic Church. Those invited to consider the RCIA are people who have never been baptized, those who have been baptized in another Christian faith tradition and would like to join the Catholic Church, and those who have been baptized Catholic but have not been Confirmed or received First Eucharist. The program currently continues gathering via video conferencing.

Despite the pandemic, we continue to provide gathering spaces for prayer, formation, and adult education. We offer communal Rosary daily, Lectio Divina, Breaking Open the Word, and "God Talk" weekly. Given these opportunities, people can pray and share faith and ideas as well as experience community. We also promote and encourage participation in Scripture courses with Loyola University's Institute of Pastoral Studies programs.

Capital Projects - Stewards of Your Gifts

We endeavor to be good stewards of our gifts and are thankful for your ongoing support. Saints JFX has a long history in Wilmette with St. Joseph Church dating back to the mid 1800's and St. Francis Xavier Church the early 1900's. We stand on the shoulders of the generous investment of past generations of Catholics in Wilmette and must take responsibility for our parish finances and facilities for the next generation.

Maintaining our Church, school buildings, and grounds is important to the safety and vitality of our parish. Over the past year, the Finance Council achieved significant reductions in parish costs by soliciting competitive bids (RFP's) for



landscaping and cleaning services at both campuses. Once the COVID-19 pandemic hit, we immediately prioritized the RFP process for cleaning services to achieve our imperative goal of safely and successfully re-opening our schools and Parish.

Other important updates that have been made to our facilities include:

- Upgraded sound system and lighting at SJ Church
- Completion of a 3-year exterior masonry project at SJ School
- Completion of the SFX School atrium and gym renovation
- Replacement of SFX Church carpeting
- Completion of the SFX Church concrete entry way
- Replacement of the vacuum pump for the heating system at SJ Church

While many of the projects were supported through previous capital campaigns, the Parish continues to rely on your generosity for ongoing maintenance and capital improvements. As we head into the next fiscal year, we are faced with a need for maintenance to our aging buildings and investment in new projects to modernize or adapt our facilities.

These uncertain times have invited us to pivot, pray and imaginatively adapt in order to continue our mission. A good example is the reconfiguration of Mass locations and schedules in response to the continuing COVID-19 pandemic. The creation of the car Mass allows parishioners to receive the Eucharist safely. Since social distancing requirements limit the number of worshipers in church, the car Mass allows many more parishioners to come and receive our Lord. So, while a number of our projects for next year will be for maintenance of our existing buildings, we persist in searching for new ways to bring our faith community closer to God.

A Look Ahead to 2021

The Saints JFX Finance Council is committed to helping our parish build its financial strength, sustaining the advancements of our vibrant community and expanding our Catholic ministries. Aligned with this objective, the Parish has assembled a Fiscal Sustainability Task Force comprised of leaders across our Finance Council, School Board, HSO and Parish Leadership team that is focused on developing a 3-Year Budgetary Plan with the following goals for our Parish:

Strengthening of the Parish's Balance Sheet

- Establishing a medium and long term cashflow positive operating plan
- Growing liquidity reserves
- Reducing deferred maintenance
- Establishing and growing a capital reserve fund for building maintenance

As referred to in the Letter from our Leadership Team, both St. Joseph and St. Francis Xavier have for some time been operating at deficits that are not sustainable. The expenses of running our parish and school significantly outweigh our income. We had a \$276,464 shortfall for fiscal year 2020. Given the pandemic impact on our expenses and income we project the shortfall for our current year will increase to \$582,253. This projected deficit for the current year is largely driven by an estimated \$740,000 contribution by the Parish to Saints JFX school. That translates to a financial contribution by the Parish of \$1,250 per student to the cost of his/her education this year. Our commitment to maintaining and enhancing the guality of the education provided at Saints JFX school is unwavering. The Parish is also committed to providing financial support to the school but going forward needs to do so at a fiscally responsible level that takes into account the overall strength of the Parish Balance Sheet and also allows for the need to support our other Parish ministries.



Over the next few months, the task force will complete its assessment and provide action-based plans for closing the budgetary gaps under

realistic, best and worst case scenarios. Action plans will be communicated to the Parish community through regular Parish and School communications, occasional Sunday Mass updates, and in next year's Annual Report.
